Re: **RESUMPTION OF PROCESS**  
A proposed amendment to the document titled "A Comprehensive Plan for the City of Racine: 2035". The amendment is titled "A Park and Open Space Plan for the City of Racine: 2035".

During the meeting of March 14, 2018 the Board of Parks, Recreation and Cultural Services (BPRCS) adopted the document titled "A Park and Open Space Plan for the City of Racine: 2035" (The Plan), and forwarded The Plan for referral. On March 20, 2018 the Common Council received The Plan and forwarded it to the Plan Commission for review and processing as an amendment to a document titled "A Comprehensive Plan for the City of Racine: 2035".

The City of Racine now resumes the process of reviewing a proposed update to the City's park and open space plan as adopted in 2011, and incorporating The Plan as an amendment to the document titled "A Comprehensive Plan for the City of Racine: 2035" (Comp Plan 2035 ). The proposed amendment is being requested so as to provide more and updated detail for the goals and objectives of the City's parks, recreation and cultural services programs and initiatives, and to update those goals and objectives as reflected in the City's Comp Plan 2035.
