You are hereby ordered to cease all operations **immediately**:

1) Observation: Relax Spa was operating as a massage parlor without obtaining a massage permit or an occupancy permit. First floor contained multiple massage rooms, a large, tiled shower room, a separate jacuzzi tub room, a room with a bed and dressers, a small size refrigerator and a small chest freezer brimming with food. Upstairs observed an apartment-like layout with all rooms connected via arched doorways and padlocks on exterior of bedroom doors. Full size kitchen, full size washer and drier, and small bathroom with a shower observed. Evidence of illegal activities of sexual nature. Evidence of permanent living conditions on premises including observation of beds, bedding, large amounts of food and cooking equipment, food actively cooking on the stove at time of inspection, and large amounts of personal effects such as clothing, toiletries, feminine hygiene products, medications, cell phones, wallets, and money. Water damaged ceiling tiles in massage rooms. Walls observed to be soiled with grime in massage rooms. Floors have accumulations of dust, dirt, and refuse. Frames of many massage tables are constructed from untreated wood and are not smooth or easily cleanable. Tops of many massage tables are constructed of a mix of various foam padding and mattress toppers covered in bunched and folded comforters/blankets and are not smooth, non-absorbent or easily cleanable. Unlabeled containers and various squeeze bottles observed holding various liquids and creams observed in all massage rooms. Clean and soiled linens do not have a system to determine if they are clean or soiled or changed between guests. Observed various medication labels with address of 403 Sixth Street handwritten on the back. Observed hot towel incubator to be turned on and towels were observed warm inside with an oil-like substance also kept at a warm temperature. Various fire violations were also observed and documented by Racine Fire Department.

Sec. 22-781. - Permit—Required.

No person shall engage in, conduct or carry on, or permit to be engaged in, conducted or carried on, in or upon any premises within the city which constitutes a massage establishment, the business of a massage establishment without having been issued a permit as provided in this division, nor without complying with all statutes, ordinances and regulations applicable to such establishment and unless such permit is in effect at the time of such operation. The permit required by this section shall not apply to hospitals, nursing homes and sanitariums.
