Alder Perez appeared before the committee. He spoke on behalf of his communication, stating that he would like to prohibit minors from purchasing or using all vaping devices.

Deputy City Attorney Arn provided the committee with an agenda briefing memorandum on whether municipalities have the legal right to ban minors of vaping products and reviewed three options that the committee could choose to take action on. After discussion, the committee chose to approve the creation of an ordinance that specifically prohibits minors from possessing e-cigarettes (including e-cigarettes that are nicotine-free) and bans the sale of such products to minors.

Alder Smetana made a motion to approve, seconded by Alder Glenn.

The committee members questioned what the fees would be and Mr. Towne explained that City Development is working with the appropriate departments to determine accurate and sufficient fees for mobile food establishment licenses.

Jarnail Singh appeared before the committee on behalf of his business Liquor Depot, located at 1401 Washington Ave. Alder Coe informed the licensee as to why he was being called in. Sergeant Webb read the recent list of incidents occurring on the licensed premise report for Liquor Depot, highlighting incidents on January 24th, 2019 and February 13th, 2019. On both dates, the licensed premises was serving alcohol without anyone on the premises with an operator's license and without the licensee present. Mr. Singh stated that an employee quit and he needed to find a replacement, but he now has an employee who does have their operator's license and explained that they now close at 9:00pm. Alder Glenn expressed concern about only having one employee on the premises with an operator's license.

Alder Coe warned the owner that if the Liquor Depot was called in for another Formal Expression of Concern within the next six months, they could face possible suspension or revocation of their license.
