Pub on Wisconsin - 525 Wisconsin Ave - Officers were dispatched in reference to an unwanted party. Unwanted party left prior to police arrival and a license premise report was completed.

Mahoffers - 236 Main St - Officers were dispatched in reference to a fight. Upon officers arrival, security was removing problematic parties from the bar. A license premise report was completed and no violations observed.

Pub on Wisconsin - 525 Wisconsin Ave - Officers were dispatched in reference to an unwanted party. Parties left prior to police arrival. A license premise report will be completed.

Taste of Soul Bar and Grill - 501 Sixth St - Officers were dispatched in reference to an unwanted party. Unwanted party was removed and a license premise check was completed with no violations observed.

Corner Kick Pub - 1301 Washington Ave - Cross reference 26-6242 - Officers were initially dispatched in reference to a civil trouble. Problematic party was removed from the establishment. Approximately 30 minutes later, officers were then dispatched in reference to a fight. The unwanted party had return back to the business and a fight ensued, arrests were made in reference to the incident. I then spoke to the bar owner who advised it was a private event that was being hosted and as they were closing the bar down, female returned and a fight ensued inside the bar. Owner was cooperative with video surveillance and a license premise report was completed.

Two Sheets to the Wind - 3316 Douglas Ave - Officers were dispatched in reference to a welfare check. Party advised her father had shown up at the bar and needed assistance. Officers did not make contact with the bar but a license premise check will be completed.

Parlay on Main St - 240 Main St - Officers were dispatched in reference to a fight. The fight was also captured on City cameras. As officers arrived on scene, approximately 75 people were in and around the street. Sgt. was on scene and reported it took approximately 15 minutes to disperse the crowd and approximately six squads responded due to the disturbance. Officers were unable to make contact at the bar due to the high volume of calls and squads being dispatched to other calls.

Parlays on Main St - 240 Main St - Officers were dispatched to a residence within the city of Racine in reference to an assault that took place. Officers later determined the incident stemmed from the large fight that occurred outside of Parlay's on Main St. Parties advised an argument ensued while inside Parlay's and eventually went outside of the bar. Party advised she was assaulted with brass knuckles and also pepper sprayed. Follow up is being conducted in reference to this incident.

Parlays on Main St - 240 Main St - Officers were dispatched in reference to an assault that took place while outside of Parlay's on Main St. Party advised they were inside the bar when an argument ensued between complainant and other parties. Party advised they were pressed up against the wall and eventually a physical altercation ensued outside. Officers made contact at Parlays in reference to the incident and they advised police they do not have video surveillance inside or outside the business.

It should be noted, in reference to all the incidents that took place. Parlay's on Main did not notify police.

Select 627 - 1111 Washington Ave - Officers were dispatched in reference to receiving information from a third party that females were going to meet up to fight. Officers arrived on scene and the complaint was unfounded. Bar appeared to be in business. A license premise report will be completed.

Follow up was made at the business and staff advised, they are unsure if cameras are located outside of the business. A license premise report will be completed in reference to this incident.

A separate caller contacted PD in reference to the assault. Report was taken in reference to the incident and it appears to be the second party to the assault report that was taken.
