#### **Call To Order**

#### Approval of Minutes for November 14, 2011 Meeting

A motion was made by Melissa Kaprelian-Becker, seconded by Michael Frontier, to Approve the Minutes. The motion PASSED by a Voice Vote.

#### **Director's Report**

Ken Lumpkin arrived at 5:20 PM Amy Schaal arrived at 5:25 PM

The Report was distributed.

Director Snow included an informational packet about the Parks, Recreation and Cultural Services' (PRCS) tree planting plans and goals developed by the City Forester. City Forester Matt Koepnick will be invited to answer questions/concerns at the January meeting of the PRCS Board.

Director Snow distributed a draft of a Legislative Forum agenda. The forum was requested at the November 14th meeting of the PRCS Board to address the impact of budget cuts on the community. Alderman Kaprelian-Becker stated that the agenda items, while important topics of discussion, do not hold relevancy to the PRCS board. Director Snow advised that, before an agenda is finalized, decisions should be made about who will convene and pay for the forum, and information gathered to ensure that this isn't already being done. He suggested that the Mayor's office may want to recommend the forum. He also advised that a small committee be formed to

determine how to move forward. The item was tabled for later discussion.

Director Snow distributed a Pershing Park Field Lights Report. He advised that the estimate for installation of field lights at Pershing Park would cost \$574,600, an amount that is in addition to the \$620,000 stated as a needed donation amount in the 2016 CIP budget. He indicated the city would not budget for such a project and that funding would need to come from donations.

Discussion of Concealed Carry of Weapons in Racine Parks

Deputy City Attorney Scott Letteney gave an overview of the law concerning concealed carry of weapons and the Mayor's directive. He advised the PRCS Board that, except where special event criteria are met and in shelter bathrooms, the city cannot prohibit/prevent the concealed carry of weapons/firearms in parks. Director Snow will follow up with the City Administrator and, at the directive of the Mayor, will see that signage prohibiting weapons/firearms is posted on park shelters.

#### **Zoological Society Report**

Director Snow explained the city's role in the Zoological Society Budget and agreed to send out another copy of its 2012 budget. Vice Chair Kaprelian asked whether the scooters donated by the DiMarco family and friends will be rented out. Director Snow indicated he will report back on this.
