#### **Call To Order**

The meeting was called to order at 5:31 p.m.

#### Approval of Minutes for the February 9, 2010 Meeting.

On a motion by Hart, seconded by DeHahn, the minutes were approved as printed.

#### 1. <u>10-4744</u>

**Subject:** Communication from the Downtown Racine Corporation requesting permission to use city right-of-way on Saturday, March 13, 2010, for a St. Patrick's Day Parade. (Res.10-1892)

Recommendation of the Public Works and Services Committee on 2-23-10: Permission be granted to the Downtown Racine Corporation to close Main Street from State Street to 8th Street, on Saturday, March 13, 2010, from 12:00 noon to 2:00 p.m., for a St. Patrick's Day Parade, with the following stipulations:

- A. A hold harmless agreement be executed;
- B. A liability insurance certificate be filed prior to this event;
- C. Any overtime costs incurred by any City department be charged to the sponsor;
- D. The sponsor shall notify all abutting property owners seventy-two (72) hours in advance of this event.
- E. The sponsor shall be responsible for all detour signage during the event.
- F. The sponsor shall pay a \$700.00 special event fee.

Further recommends that the Commissioner of Public Works/City Engineer and Chief of Police provide limited assistance, in the interest of public safety, to implement this event.

FISCAL NOTE: There will be nominal costs to various City

Rick indicated this is comparable to past request and requested it be approved.

## 2. <u>10-4743</u> **Subject:** Communication from business owners on Sixth Street requesting that the bench in the 500 block of Sixth Street be moved.

### Recommendation of the Public Works and Services Committee on 2-23-10: Defer

Pete Karas wants the bench to face the street and placed on the north side of the street. Rick noted the two benches between Park and Villa Streets can't be turned around as they are only 2' from the curb and to turn around, would need 3' for ADA compliance. He recommended that the item be deferred to contact DRC to fund the purchase of benches and we can install additional benches in this block. The benches cost is about \$1,200 and \$200 to 300 to install.

On a motion by Hart, seconded by DeHahn, the Committee deferred the item until DRC could be contacted about additional benches and abutting property owner over the location of the benches.

#### 3. <u>10-4776</u>

**Subject:** (Direct Referral) Communication from the Commissioner of Public Works/City Engineer submitting bid results on Contract 2-10 (K0-002), Incinerator Building Structural Slab Repair. (Res.10-1893)

Recommendation of the Public Works and Services Committee on 2-23-10: That Contract 2-10 (K0-002), Incinerator Building Structural Slab Repair, be awarded to Seater Construction Co., Inc., Racine, WI, at their bid price of \$84,000.00, plus Alternate Bid #1 at \$5,900.00 and Alternate Bid #3 at \$2,500.00, for a total contract amount of \$92,400.00, they being the lowest responsible bidder.

Further recommends that funding to defray the cost of this public works project be appropriated from Account 990.220.5030, Central Heating Plant - Structural Repairs.

Rick explained there were 11 bidders and suggested the bid go to Seater Construction at their base bid of \$84,000, plus Alternate 1 and Alternate 3 for a total of \$92,400.

On a motion by Hart, seconded by DeHahn, the Committee approved Seater Construction they being the lowest responsible bidder and authorized the Mayor and City Clerk to enter into a contract.

Rick noted we got the first 2 of 3 checks in the amount of \$100,000 and \$50,000 scheduled on 3/10/10 and \$33,000 for lighting retrofit project in the future as well for a total of \$183,000 in grant funds. He explained this was informational and no action was needed.

Rick explained we did not receive the TIGER Grant funds for our project and the only Wisconsin project funded was received by Milwaukee for 2 lift bridge repairs. This was informational and no action was necessary.
