The General Manager introduced James Burdick from Clifton-Gunderson. He explained the "Auditor's Responsibility Under Generally Accepted Auditing Standards". It was also suggested that the General Manager review and approve the journal entries made by the Administrative Manager. In summary, he stated that the financial statements present fair, in all material respects, the financial position of the Racine Wastewater Utility as of December 31, 2006 and 2005, and the results of its operations and cash flows for the years then ended, in conformity with accounting principles generally accepted in the United States of America.

Commissioner Pellegrom made a motion, seconded by Commissioner Staeck, to approve the Wastewater Utility Financial Statement from December 31, 2006 and 2005. Furthermore, refer it to the Finance and Personnel Committee for approval. The motion passed unanimously.

6. <u>07-0772</u> **Subject:** Compliance Maintenance Annual Report (CMAR) for 2006

## Recommendation: Approve

The Wastewater Plant Superintendent submitted the 2006 Annual Report for the Wastewater Utility. He noted that the Utility received a Grade of "A" in all categories except one. We had 3 bypasses last year. In the category of "Collection Systems, the Utility received a Grade "D". As a result, the Department of Natural Resources requires the Utility to come up with a plan of action to eliminate safety site overflows in the collection system. Therefore, a Compliance Maintenance Resolution has been created for the Department of Natural Resources indicating the Utility's action response plan and implementation schedule.

Commissioner Hewitt made a motion, seconded by Commissioner Pucely, to approve the Compliance Maintenance Resolution for 2006 for submittal to the Department of Natural Resources. The motion passed on an 8-0 vote.

7. <u>07-0789</u> **Subject:** Wastewater Utility Annual Report

## Recommendation: Receive and File

The General Manager submitted the 2006 Annual Report for the Wastewater Utility. He noted that the WPDES permit is up for renewal next year which may include a limit on ammonia levels, which he made note on the ammonia graph in the report that the Utility shouldn't have a problem with this. He mentioned that the cost of natural gas has gone from \$171,159.00 in 2001 to \$305,599.00 in 2006. He also mentioned that the cost of electricity has gone up from \$210,375.00 in 2001 to \$489,939.00 in 2006, and should expect an increase of 7.5% for 2008 and 2009. He also pointed out that the pretreatment program has been successful in that violations are down as compared to previous years.

The General Manager mentioned that the Utility is working with dental offices that deposit mercury (amalgam) into the collection system. An ordinance has been created with guidelines for disposal of amalgam. The General Manager noted that the Utility has had good responses from most dental offices. He recommended that this item be referred to the Public Safety and Licensing Committee and the Public Works and Services Committee for further consideration.

Commissioner Staeck made a motion, seconded by Commissioner Lui, to approve Ordinance No. 13-07 with regard to amalgam management at dental offices. Furthermore, that this item be referred to the Public Safety and Licensing Committee and the Public Works and Services Committee.
