Ord.05-15	Ordinance 05-15 - Appointment of Humane Officers
	An ordinance to create a section in Chapter 2 - Administration, Article Departments, Division 6 Police Department, of the Municipal Code the City of Racine, Wisconsin for the appointment of humane officers.

The Common Council of the City of Racine, Wisconsin do ordain as

<u>Part 1</u>: To amend - Administration Chapter 2, Article IV Departments, Division 6. - Police Department of the Municipal Code of the City of Racine, Wisconsin by adding the following section:

"Sec. 2-412. - Appointment of Humane Officers

- (a) The Common Council shall appoint one or more humane officers. Humane officers shall have all of the powers and duties established under Wisconsin Statutes Chapter 173.
- (b) The Chief of Police is hereby designated as the official who may modify or withdraw abatement orders issued pursuant to Section 173.11, Wis. Stats."

Part 2: Sections 2-413 - 2-430 are hereby reserved.

<u>Part 3</u>: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.

Ord.06-15 Ordinance 06-15

An ordinance to amend Sec. 22-1066. - Driver's licenses-Required; application of the Municipal Code of the City of Racine, Wisconsin to prohibit issuance of a public passenger vehicle license to applicants with OWI convictions within the past five years.

The Common Council of the City of Racine, Wisconsin do ordain as follows:

<u>Part 1</u>: To renumber subsection "(d) *Action on application*" to subsection "(e)" in Chapter 22, Article XXVIII, Division 3. - Drivers, Sec. 22-1066. - Driver's licenses-Required; application of the Municipal Code of the City of Racine, Wisconsin.

<u>Part 2</u>: To amend Chapter 22, Article XXVIII, Division 3. - Drivers, Sec. 22-1066. - Driver's licenses-Required; application of the Municipal Code of the City of Racine, Wisconsin by adding the new subsection (d) as follows:

"(d) No license shall be issued to any applicant who has an OWI conviction within the previous two years or two or more convictions within the previous five years."

<u>Part 3</u>: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.
