AMENDMENT

This amendment ("Amendment") is made this ______ day of February, 2015 by and between Tyler Technologies, Inc. with offices at One Tyler Drive, Yarmouth, Maine 04096 ("Tyler") and the City of Racine with offices at 730 Washington Avenue, Room 103, Racine, Wisconsin 53403 ("Client").

WHEREAS, Tyler and the Client are parties to an agreement effective April 10, 2014 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the Agreement;

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the Client agree as follows:

- 1. The Tyler Software Products and services in the attached Sales Quotation 2015-11272, attached hereto as Exhibit 1, are hereby added to the Agreement.
- 2. Payment for items added to the Agreement pursuant this Amendment shall conform to the following:
 - a. Tyler shall invoice Client \$46,406.25 when Tyler has made the Tyler Software Products available to client for downloading. Such sum equals 75% of the Tyler Software license fees.
 - b. Tyler will invoice the remaining 25% of the Tyler software license fees (totaling \$15,468.75) for the Tyler Software Products upon the terms set forth in paragraph 28 (e) of the Agreement.
 - c. Tyler shall invoice Client fees for the "Implementation Costs" (\$23,500.00) set forth in the Investment Summary, if and as provided to the earlier of (i) the date of first productive use of the Tyler Software Products using actual Client Data ("Live Production"), unless such Live Production is postponed by Tyler's failure to perform, in which event the date for such Live Production will be postponed the corresponding number of days.
 - d. Tyler shall invoice Client fees for Data Conversion services as follows:
 - a. 50% upon initial delivery of converted data, by conversion option;
 - b. 50% upon Client acceptance to load converted data into live environment (automatic, electronic notification), by conversion option.
- 3. Client agrees to purchase and Tyler agrees to provide maintenance services for the Tyler Software Products added to the Agreement pursuant this Amendment in accordance with the terms of the Agreement. The initial Maintenance term shall be prorated for a term commencing on the date when Tyler makes the Tyler Software Products available to Client for downloading (the "Available Download Date") and ending concurrently with Client's current annual maintenance term. Following the initial term, subsequent maintenance will be provided in accordance with the terms of the Agreement.
- 4. Unless otherwise provided herein, services added to the Agreement pursuant to this Amendment, along with applicable travel expenses, shall be invoiced as provided and/or incurred.

- 5. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
- 6. All other terms and conditions of the Agreement shall remain in full force and effect.

This certificate is required to encrypt the highly sensitive payroll and financial information as it travels across the public internet. There are various vendors who sell SSL Certificates, with all ranges of prices.

Conversion prices are based on a single occurrence of the database. If additional databases need to be converted, these will need to be quoted.
