Al,

I have a request from the mayor to consider moving a bus stop located near 3642 La Salle St. This stop is on the west side of the street for south bound traffic, across the street from Jerstad-Agerholm middle school. As is the case with many bus stops that serve students, we get complaints about vandalism, trespassing, etc. from residents whose homes are near these stops. There is already a request like this for 700 Villa St. on the agenda for the Transit and Parking commission this month. Please have this stop considered at the same time. Either add this to the current agenda item or have another item created and direct refer it to this agenda.

The homeowners related to the mayor that at one time the southbound bus did not stop at this location, but actually entered the school parking lot to pick up students. In that way they assembled for pick-up on school property. My guess is that we made the change to improve transit time and/or to limit the liability of driving on school property.

If you have questions relating to the reviewing procedure, please give me a call. I am sure that there are numerous ways to address these requests and I am open to any of them.
