# 11. 12-8077 Subject: Request from BRP for a Low Capacity Well in Sturtevant - Joe Muratore Invited to the Meeting

The General Manager noted that BRP, a company located in the Village of Sturtevant, would like to have a low capacity well. He stated that the Utility has met with BRP representatives and they are in disagreement and are deficient in answering questions asked by the Utility.

Authorize the General Manager of the Racine Water Utility (RWU) to work with Attorney Joe Muratore to develop ordinance changes in Sturtevant to ensure that ordinances are fully consistant with the Retail Water Agreement such that new residential, commercial, and industrial developments obtain water exclusively from the Racine Water Utility.

Further, authorize the General Manager of the RWU to send a letter to BRP expressing its displeasure with their decisions regarding water sourcing for their new expansion.

Further, authorize the General Manager of the RWU to explore all options that the Racine Water Utility may have for responding to BRP's actions regarding water sourcing for their new expansion.

Further, authorize the General Manager of the RWU to send a letter to Sturtevant regarding violation of the Retail Water Agreement and ordinances in the Village of Sturtevant.

Further, authorize the General Manager of the RWU to work with Attorney Joe Muratore to review ordinances in other municipalities and suggest revisions in those communities with regard to the retail water agreements.
