117. Res.06-7042 90 DAY MORATORIUM FOR CONVENIENT-CASH BUSINESSES

WHEREAS, the City of Racine has experienced a proliferation of "convenient-cash" businesses and similar businesses such as check-cashing businesses, payday loan stores, etc., that make non-traditional, short-term consumer loans; and

WHEREAS, "usury" is an unconscionable and exorbitant rate or amount of interest, and the presence of a usurious rate makes a loan agreement unethical or sometimes illegal, in whole or in part; and

WHEREAS, instead of offering a product that enables borrowers to escape emergencies, payday lenders 'flip' borrowers, renewing their loans repeatedly for high fees without extending further credit, which traps borrowers into paying back many times the amount of the original loan at annual interest rates that are typically 400 percent or higher; and

WHEREAS, the clustering of payday loan agencies in and around economically disadvantaged neighborhoods causes severe financial problems for the residents of those communities; and

WHEREAS, research has shown that such businesses target minority neighborhoods; and

WHEREAS, convenient-cash businesses, because of the frequency of cash transactions and the amount of money exchanged, are attractive to criminals seeking to commit robberies; and

WHEREAS, the health, safety and welfare of Racine residents should be

protected by legislation limiting the geographic concentration of convenient-cash businesses and similar establishments and the proximity of such establishments to residentially-zoned areas.

NOW, THEREFORE, BE IT RESOLVED, that the Common Council of the City of Racine hereby imposes a 90 day moratorium upon the granting of any occupancy permit for a convenient-cash business or similar establishment to provide time for the Common Council to develop and implement ordinances containing appropriate restrictions for the establishment of such businesses.

120. <u>Ord.20-06</u>

Ordinance No. 20-06 to amend Sec. 114-1, create Sec. 114-638.5, amend Sec. 114-824, amend Sec. 114-826(4) and amend Sec. 114-827 of the Municipal Code of the City of Racine, Wisconsin relating to Zoning - Mapped district.

Part 1:

Sec. 114-1 of the Municipal Code of the City of Racine is hereby amended by adding the following definition after the definition for "Extended medical care facilities":

"Facility or facilities means those physical attributes of a use including, but not limited to, landscaping, trash handling, parking and drive areas, lighting, utilities, signage, display or storage areas, equipment and buildings and appurtenances."

Part 2:

Sec. 114-638.5 of the Municipal Code of the City of Racine is hereby created to read as follows:

"Sec. 114-638.5. Applicability.

- (a) Design guidelines contained in this division shall apply to all facilities such as, but not limited to, office, commercial, residential facilities containing five or more living units, lodging, museum, theater, governmental, parking and utility facilities, excepting that maintenance and repair activities that do not alter the property's exterior design features are exempt from the requirements of this division.
- (b) The Access Corridor Development Review Committee shall review projects within those portions of the State Street corridor district that are also within the River sub-district and lie west, north and north-west of the Root River, and areas within the State Street corridor sub-district, as described in the "Downtown Design Standards" adopted by common council resolution no. Res.06-7041 of May 16, 2006, using the design considerations contained in that document and in the "Downtown Design Guidelines adopted by common council resolution number Res.06-7040 of May 16, 2006."

Part 3:

Sec. 114-824 of the Municipal Code of the City of Racine is hereby amended by adding "(a)" at the beginning of the paragraph and by adding the following paragraphs after "(a)":

- "(b) Sub-districts within the Downtown area are: River, State Street corridor, Marquette corridor, Sixth and Seventh Streets corridor, Main Street corridor, Marina, and Gaslight. Each sub-district presents opportunities and challenges that warrant individual design considerations as contained in the "Downtown Design Standards" adopted by common council resolution number Res.06-7041 on May 16, 2006.
- (c) The Access Corridor Development Review Committee shall review projects within the River sub-district located west, north and north-west of the Root River, and areas within the State Street corridor sub-district, using the design

considerations contained in the "Downtown Design Standards" adopted by common council resolution number Res.06-7041 of May 16, 2006."

Part 4:

Sec. 114-826(4) of the Municipal Code of the City of Racine is hereby amended to read as follows:

"(4) Maintenance and repair activities that do not alter the property's exterior design features are exempt from the requirements of this division."

Part 5:

Sec. 114-827 of the Municipal Code of the City of Racine is hereby amended by adding the following paragraph at the beginning of the section:

"(a) Persons contemplating a project in the Downtown Area should review the Downtown Design Guidelines and Downtown Design Standards adopted by common council resolutions Res.06-7040 and Res.06-7041 of May 16, 2006, as guides in understanding the purpose, scope and intent of this division."

And by inserting "(b)" before the existing paragraph and by inserting the following phrase after the word "residential" in the first sentence: "facilities containing five or more living units".
