Subject: Policy Decision on Raising Employee Share of Medical Expense Premium from 7.5% to 10%

Recommendation: Approve to keep employee share of medical expense premium at 7.5% with the option of participating in a 5% premium plan with a higher out-of-pocket expense

The General Manager noted that the Finance Committee of the Board of Wastewater Commissioners recommended that the health care premium for Wastewater Utility employees stay at 7.5% for employee share for employees currently paying 7.5%. Also, all employees would be able to participate in a 5% premium plan with a higher out-of-pocket expense, which the City is offering. Furthermore, employees would have to pay their own premium if they chose the option of having dental care. For recent hires paying a 10% premium, the Utility will pay for single dental coverage.
