## BOARD OF HEALTH MEETING March 13, 2007

**DEPARTMENT: Community Health Programs (CHP)** 

**REPORT FOR THE MONTH OF: February 2007** 

#### **Highlights:**

- Jeff Schmidt, Epidemiologist, presented information on sexually transmitted infections at the Racine Youthful Offender Correctional Facility on February 1.
- o Diane Lange gave a presentation on teen pregnancy issues to the Delta Kappa Gamma sorority and obtained a donation for Youth Connections.
- o Jeff Schmidt attended the Black HIV Awareness Conference on February 3 to perform Rapid HIV testing for conference participants.
- On February 7, the public health nursing staff met with the supervisor and a family advocate from Next Generation Now and the coordinator and Home Visitor from Family Smart Kid Friendly to discuss ways to work together to serve clients in the community.
- Weekly immunization clinics have been busier in February due to the Racine Unified School District excluding students in grades 2-12 who were not in compliance with state immunization requirements.
- We have received notification that the state will supply the vaccine for HPV for use in our clinics. It will be available for girl 9-18. Orders have been signed and vaccine ordered so we expect to begin giving the vaccine in March.
- The public health nurses have begun holding group educational sessions for pregnant women in the PNCC program. On February 5, Marcia Rottino hosted a class along with Heidi Laundrie from WIC, and Kelly, the Enrollment Specialist for Medicaid. They presented information on prenatal development, prenatal nutrition and Medicaid. Two clients attended on a very cold day. On February 22, Sue Napier, Pat Anderson, and Karin Dinda presented a class on premature labor, shaken baby syndrome and SIDS. Five women attended. Clients receive layette items as an incentive and reward for attended classes.
- We received several calls from residents with questions about the recall of contaminated peanut butter. There were many residents who had the peanut butter with the recalled lots. One client was tested but did not show positive tests. Others were referred to their physicians. Residents were advised to destroy the remaining peanut butter or return it to the store.
- The Racine Infant Mortality Coalition (RIMC) continues to receive newspaper coverage and is meeting regularly. A City of Racine paramedic presented information on a "Cribs for Kids" program at the meeting on February 19. This program would provide cribs and education on safe sleeping conditions to parents. The group is also working on getting messages about having healthy pregnancies out to the public. Pat Anderson and Thelma Jones represent the Health Department in this group.
