# **Application Instructions**

## **Fees**

A base permit fee shall apply for all parades or processions. For parade routes exceeding ten (10) blocks, a per-block fee shall be assessed for each additional block beyond the initial ten, with all fees established by the Common Council through resolution. This fee structure shall assist in offsetting public safety costs, including overtime for the Racine Police Department.

## **Denials & Appeals**

If the Public Safety and Licensing Committee denies the application, the denied application shall be presented to the Common Council for consideration. If the applicant is aggrieved by conditions established by the Racine Police Department, the applicant may appeal such conditions to the Public Safety and Licensing Committee within fifteen (15) days of notification.

## **Enforcement**

Any parade, procession, or open-air meeting held without an approved permit shall be considered a violation of this section and subject to enforcement under the City's general penalty provisions.

**Please make sure you have a copy of the parade route attached to the following permit.**

**This application must be submitted to the City Clerk/Customer Service Office at least 60 days prior to the scheduled event date. Applications are subject to approval by the Public Safety & Licensing Committee, the Common Council, and the Racine Police Department.**
