Fiscal Note: The assessment for paving and for the sanitary sewer laterals will remain as originally approved. The only change is the reduction for the property owner of the assessment for the sanitary sewer mainline as indicated above.

Rick noted the owner did not meet the financial requirements as far as income for CDGB eligibility. During some research of previous sanitary sewer assessments on corner lots, he noted an issue on Homestead Drive in 1982 whereby the corner lot only paid for the sanitary sewer in specific circumstances. This circumstance is very similar and determined a reduced assessment could be made from the original to extend sewer to the property at 211 15th Street. The reduction in the assessment would be from \$26,0000 to less than \$5,000.

On a motion by Weidner, seconded by Hart, the Committee approved installing the new sewer and lateral and calculate the new assessment cost to the owner at 211 15th Street.

The agreement stipulates the City of Racine reimburses for annual and routine maintenance and utility costs at 25%, since 1/4 of intersection is in the City corporate limits.

A. John submitted bid results from the Wisconsin Department of Transportation's web site for 6th Street construction in downtown Racine. He noted the apparent low bidder was A. W. Oakes of Racine, Wisconsin, in the amount of \$1,871,237.96. The engineer's estimate was \$2,070,000.

This is informational and no action is required.

B. Ray DeHahn inquired about a meeting with Caledonia officials regarding Three Mile Road. Rick informed him of the status of the project and noted the Village is looking at different options to do shorter segments of the project, and the City and Village will meet again after the new year.
