Director Molbeck appeared to discuss the item. He recommended continuing the relationship with UW-Parkside because without them there would be no programming at the REC site. He noted that UW-Parkside is interested in not paying utilities, which amounts to \$900–1000 per year, as a part of this agreement. Committee members had questions about the program and expressed concerns about taking on the utility costs. Chairman Helding noted that any agreement would have to meet the constraints of the current budget and any change in funding would have to return to council for approval. Alderman Perez moved to approve the request, and Alderman Kaprelian-Becker seconded the motion. The motion carried on a voice vote.

Alderman Kaprelian-Becker moved to: 1) direct the City Attorney to draft a letter from the Committee to the Police Chief and District Attorney to review at the next meeting, 2) invite the Police Chief to the next meeting, and 3) defer the item to the next meeting. Alderman Morgenroth seconded the motion, which carried by unanimous consent.
