1. Executive Summary

#. Business Overview

George's Tavern was founded by brothers Chris and George Popoff in 1946 as a community hub built around "Food, Fun & Friends". Over the past 70- years it has developed and grown into a neighborhood tavern featuring homemade food, live music, and a hometown atmosphere.

George's Encore will embrace the history of George's Tavern and build upon what it known for in the community. Unique to the establishment, is the adjacent dining room, that is mostly used for live music and has some of the best sounding acoustics in the area. Live music will be a strong focus of the relaunch with scheduled performances at least three days per week. One of the target markets is "music loving individuals 40 and older" and the music selection will reflect that with cover bands playing 60s&70s music, Blues, Rock n Roll, R&B, and Deadhead. Another focus in the relaunch will be the food menu witch will based in a homemade style manner featuring items such as chili, soups, burgers, hot beef sandwiches, homemade pizza & standard bar food.

The last, and most important, item to focus on is "Friends." A community/neighborhood bar is successful by bringing people together. This will be accomplished by continuing George's traditions such as Fundraisers, car shows, flee markets, sponsoring spots teams. One of George's Encore's financial goals for year one is to gross a minimum of \$360,000 in sales while maintaining control of COGS and providing Exceptional service. Building upon the base sales, George's Encore plans to generate profit within the first 15 months of operations with repayment of all startup investment.

George's Encore is a Community Bar focused on bringing people through Live Music and Great Food resulting in Greater Friends. "Music, Food, Friends" We will be able to achieve our mission through investment in the local music industry, creating a home-style menu, collaborating with the community and above all, providing exceptional service in all contacts.

George's Encore will be focused on providing exceptional customer service with a focus on building a community relationships. The menu, drink selections, and music will reflect the diverse Racine community while providing a variety of options at a fair price. A guiding principle of treating others with respect and dignity will be reflected in all of our encounters, starting with management and employees and extending to customers and suppliers.

Integrity shall take precedent in all decisions regarding the business. Whether that pertains to staff assisting customers, management assisting staff, relationship with bands, or menu development and decisions.

e. Keys to Success

The success of George's Encore leans upon the development and implementation of a plan that follows our mission while adhering to our principles. Systems, standards, and procedures will also play an important part to ensure we are reaching our goals financially and honorably. Specific keys include:

- 1) Outstanding customer service: Satisfied customers are essential to sustainability, growth, and profitability of the business.
- 2) Live music and Events: George's Encore is a live music venue, especially on weekends. Ensuring the back room asset is utilized to draw in new and repeat business is essential to reaching goals.
- 3) Quality Food and Drinks: A "Home-style" menu will attract a diverse crowd as well as reach our target market. A wide variety of drink options will also keep customers satisfied. We will feature some vintage drinks to celebrate the age of Georges: Manhattan, Old Fashion, Martinis, Tom Collins, and Gimlet \$\frac{1}{2}\$

2. Company Summary

a. Business Overview

George's Encore will occupy the 2500 square foot location at 1201 N. Main Street, Racine WI 53402 which was previously occupied by George's Tavern for the Previous 77 years.

George's Encore will be operated as a Community Dive Bar with a focus on live music, home-made food, and building friendships. The environment/furnishings of the bar will embrace the history of both the building and the previous operators while emphasizing live music and the community. The décor will reflect the age of the building by emphasizing the age of the back bar, seating and lighting will be vintage in design. Signage and décor of the facility will emphasize the history in regards to music acts that have performed at George's as well as highlight the previous owners and its relationship to the city throughout the decades.

b. Ownership

George's Encore will be solely owned by the proprietor, Caleb Robinson, who has over 12 years of experience in the bar/live music venue experience. He will be 100% owner of the entity but may sell some interest if the right partner/manager emerges.

George's Encore will be focused on offering a historical menu for both food and drinks. As a dive bar, the beer and cocktail menu will feature popular items within the bar industry such as: Miller Lite, Budweiser, Rum based drinks, and vodka based drinks. However, we will expand upon that with a historical view reaching back to classics such as PBRs, Hamm's, Tom Collins, and Manhattans. The Food menu will follow a similar concept by offering classic bar fair foods like fries, burgers, and wings but more importantly in will focused on Home-Style cooking with items as Soups, Smash Burgers, Hot Beef Sandwiches, lasagna, and dinner plates.

c. Product/Services Sourcing

By State Law, all alcoholic beverages for retail must be purchased through a distributor and therefore local distributors will be utilized for that such as: CJW, Beechwood, WI Distributors, Badger, Capitol Husting, Johnson Brothers, and Ratas.

With a Home-style menu we will try and source food products from local vendors such as Farmers Markets and Piggly Wiggly. Storage is currently minimal and therefore multiple food runs per week may be needed. However, We will use either Sysco or Reinhart distribution for weekly delivers. Cost and quality will dictate which vendor is utilized.

Serving utensils (Plates, Bowls, Cups, Silverware, etc.) will keep with the theme of Home-Made and be of classic design and washable/reusable.

d. Inventory Management

Cost controls are an important part of running a profitable business and therefore we will be utilizing a POS (Point of Sale) system to track inventory. Inventory will also be checked by management to look for gaps and for ordering. Ordering guidelines will be built around maintaining a minimum amount. Theft and handouts are also a concern in a cash business and therefore strong inventory management procedures will be in place and enforced.

e. Future Products/Service

George's Encore will be dedicated to the improvement of operations and customer service while aligning to the goals and mission of the business. This may entail shifts in food offerings, drink menus, event night scheduling (such as adding trivia, bingo, cribbage, or other shows) and also review the allocation of services to best accommodate customer and staff needs. For example, revisiting the idea of servers on busy nights or cocktail waitress could be an option to improve overall satisfaction. 
