REPORT FOR THE MONTH OF JANUARY:

Highlights:

- The City of Racine was awarded a Lead Hazard Demonstration Grant from the U.S. Department of Housing and Urban Development (HUD) in partnership with Kenosha County. The program is the *Kenosha/Racine Lead-Free Communities Partnership*. The amount is \$3,996,928 for a three year grant cycle and is expected to commence in February of 2007. The monies will be used to identify and control lead based hazards in at least 200 homes in each community. The grant will also provide education and outreach for lead poisoning prevention.
- For 2006, there were a total of 107 children who had elevated lead levels \geq 10 µg/dL. There were 3,441 children tested. For 2006, 3.1% percent of children tested had elevated levels compared to 5.3% for 2005.
- January 25th, Racine City Health Department and Countryside Humane Society held a rabies vaccination and licensing clinic at City Hall from 5:30 7:30 p.m. The clinic was very successful; thirty-five animals were seen at the clinic.

Outcome Achievements:

- Two hundred and forty seven (247) children tested for lead poisoning had blood lead levels between zero and nine ug/dL (0-9 ug/dL).
- Preliminary reports identify that eighty nine (89) children were <u>first</u> tested for lead poisoning; four (4) had an elevated blood lead level (>9ug/dL), or 4.5 %.
- Preliminary reports identify a <u>total</u> of two hundred and fifty eight (258) children as being tested for lead poisoning; eleven (11) had an elevated blood lead level (>9ug/dL), or 4.3%.
- The number of 2007 city dog licenses obtained to date is two thousand eight hundred and sixty eight (2,868).
- The number of 2007 cat licenses obtained to date is seven hundred and seventy one (771).
- Eighty nine (89) pet fanciers' permits have been issued in 2007.
