

Congratulations on your commendable performance during the alcohol compliance check conducted at your workplace by City of Racine Police Department.

On 4/15/11 at 5:12 pm, an underage customer entered your place of business and attempted to buy alcohol and was denied. Your employee asked to see a valid ID and did not proceed with the sale. Your employee's decision to refuse alcohol sales to our underage buyer reflects your business's commitment to being a responsible member of the alcohol sales industry. We appreciate your compliance with state and local statutes prohibiting the sale of any alcohol beverage to a person under the age of 21. We commend you and your employees' continuing efforts at reducing youth alcohol use in our community.

Our efforts to encourage compliance to alcohol retail laws have been ongoing since 2004 and compliance checks will be completed periodically throughout the year. Since we began conducting alcohol compliance checks for your establishment in 2005, underage youth have been sold to once. A total of seven alcohol compliance checks have been conducted and a sale was made in the spring of 2007.

There are training opportunities available locally and online, such as TIPS training, to help prepare employees and management to sell alcohol responsibly. In certain circumstances, the Racine County Youth Coalition is able to help local business cover the cost of training for alcohol retail employees.
