## NARRATIVE

I also observed that the BLUES and R&B Bar was serving food inside the bar and at a walk up window. Once people received their food, they were eating the food in their vehicles and on their vehicles. BLUES and R&B was also using their loud speaker outside to announce food orders that were ready for pickup.

The time I noticed this disturbance was between the hours of 2:30a thru approx. 3:30a, due to calls for service, I could not act on some of the violations created by the vehicles, as in, illegally parked and loud music. This distrubance is a quality of life issue for the people living in this neighborhood and directly related to BLUES and R&B serving food at their establishment after Tavern closing hours.
