Molbeck briefly discussed the parking lot improvements made at Chavez Community Center. The parking lot is now larger in size which will benefit the visitors and participants at the center.

Molbeck advised approximately 100 people attended the annual Monument Mash event which took place on October 18, 2014. The poor weather conditions was believed to have caused the low attendance.

McCarthy asked Molbeck to explain the PRCS 2015 Budget proposal. Molbeck addressed the concerns and misunderstanding Humble and Tyler Domer Community Centers would be shut down. This is not the case. There will, however be a reduction in open recreation hours. Currently there is a plan to have open recreation for two hours after school Monday through Thursday for the duration of the school year. There will be programming at each center throughout the summer. The goal is to secure funding through sponsorship, etc. to allow open recreation in the fall through the end of the year.

Molbeck explained donations and grants are never guaranteed. There seems to be a huge concern over the reduction of the open recreation hours. There are grants available for programming; however to find a grant to pay wages for open recreation may not be possible.

Sarrazin inquired if PRCS has the staff to assist with additional fundraising efforts and application of grants. Molbeck stated there is not. What PRCS staff does already to find funding sources for programming and activities takes a tremendous amount of time not only for the individual seeking out the funds, but for office staff as well.

A motion was made by Kristen Kaprelian and seconded by Pam Handrow to Receive and File the report. The Motion PASSED by Voice Vote. Unanimous.
