THE FIFTEEN-EIGHTEEN has opened and provides a unique restaurant/event hall in the uptown area, providing a safe space for residents to gather to celebrate weddings, corporate events, birthday parties, comedy shows, re-passes for families celebrating the loss of a loved one and many other events. I have also provided employment opportunities for many inner city unemployed residents as well.

Upon opening it has come to my attention the original business hours were 8:00am-12:00am Monday-Sunday is not meeting the needs of majority of my customers. Before my team and I completed the project and I opened up, I had minimal experience. Since then I am learning that my peak hours would be after 12am where I can make the most money. My food sales are not doing the projected numbers because closing before 12:00am I cannot capitalize after. I would like to modify my hours and operate from 10:00am-2:00am Wednesday-Sunday. Many potential customers have expressed utilizing our establishment but the current hours would preclude THE FIFTEEN-EIGHTEEN LLC from hosting some of the previously mentioned events.

To address the issue of security, THE FIFTEEN-EIGHTEEN LLC has hired an armed security company for all events inside the business, outside the exterior of the building to include the rear parking lot and installed tons of cameras. I hired Officer Jordan Payne when he is available. I am also welcomed to bring more officers onsite.
