<u>Aleisha Djuricic (218 Lombard)</u> – Opposed. Still paying for previous work that was done on Lombard which cost over \$5,000.00.

<u>Joe Graceffa on behalf of Anna Kucera (3215 Chatham)</u> – Opposed. He is also opposed to the cost.

<u>Ed Willneff (3306 Chatham)</u> - Opposed. Block is not in bad shape, asked what is the primary factors were in determining which streets needed repair.
