## **BUS General Manager's Operations Report**

For September 2017 compared to 2016: Fixed route transit ridership was down 5%. Paratransit was down 3%; Revenue was down 11% for fixed route and down 4% for paratransit.

Overtime was up 120% in September compared to one year ago.

For the first three quarters of 2017 compared to 2016: Fixed route transit ridership was down 3%. Paratransit was up 2%; Revenue was down 4% for fixed route and up 4% for paratransit. Overtime was up 47% compared to one year ago.

Maintenance cost was at budget because some expensive items that were replaced previously are now working well.

## Transit and Parking System Manager's Report

The manager is beginning discussion with partner communities and will look for increases on the same order as the City of Racine's budget.

RYDE to Work week provided an opportunity to network with community groups and companies. Riders seemed to enjoy snacks at the transit center.
