- 5. That any temporary signage be in place no longer than 30 days.
- 6. That new awning match dimensions of current awning, be faced in the color and fabric style submitted and that the awning structure receive formal approval from the City to be placed within the right-of-way.
- 7. That no minor changes be made to the conditions of this approval without the review and approval of the director of city development, and no major changes be made without the approval of the DADRC.
- 8. Final approval by the DADRC will occur on May 2, 2019 meeting as a consent item.
