Call To Order

The meeting was called to order at 5:30 p.m.

Approval of Minutes for the October 30, 2007 Meeting.

On a motion by Karas, seconded by Anderson, the minutes were approved as printed.

1. <u>07-1253</u>

Subject: Communication from the Commissioner of Public Works/City Engineer regarding the lease agreement with James J. Mauer for use of river frontage at the terminus of Superior Street at the Root River.

Recommendation: The Mayor and City Clerk be authorized and directed to enter into a lease agreement with Peter R. Mauer for use of 60 lineal feet of river frontage at the terminus of Superior Street at the Root River, including the right-of-way to the south line of Liberty Street excepting that portion which is utilized by CNH, Inc. as a driveway entrance, for a three-year period from January 1, 2008 to December 31, 2010 subject to the terms and conditions contained in the lease agreement dated April 14, 2000, except that the yearly annual rental shall be increased by 3% per year beginning with a rental rate due in January 2008 of \$728.85.

Fiscal Note: This agreement will result in approximately \$2,250.00 in revenue to the City of Racine over the three-year period.

James and Peter Mauer appeared before the Committee and requested their lease agreement be extended. Rick noted he had no objection and stated the area is used to launch charter boats. A three year lease would be appropriate with a 3% increase per year.

On a motion by Karas, seconded by DeHahn, the Committee approved the extension and authorized the Mayor and City Clerk to enter into the agreement.

Recommendation of City Plan Commission on 11-14-07: That the land transfer is consistent with City plans and programs.

Jan Roland appeared before the Committee and asked the City to ask the County to transfer a small piece of non-buildable property near 1124 12th Street. There was some confusion as to the exact portion of property to be transferred. Rick suggested the item be deferred while Brian O'Connell investigates the legal description and provide a more accurate description to the Committee.

Subject: Communication from Sam Azarian Jr. wishing to discuss purchasing the Marquette Street municipal parking lot.

Recommendation of the Transit and Parking Commission on 5-30-07: The Marquette Street municipal parking lot be sold to Sam Azarian Jr. for a cost of \$1 contingent upon the upgrade of fencing and landscape, and the separation of lighting circuits.

Fiscal Note: The sale will generate \$1 to the Parking System

Recommendation of the City Plan Commission on 6-13-07: That the proposed sale is not in conflict with adopted City plans and programs.

Further, that the sale be approved.

Fiscal Note: The sale price of the property will be determined by the Public Works and Services Committee.

Recommendation of the Public Works and Services Committee on 11/13/07: The Mayor and City Clerk be authorized and directed to enter

into a lease agreement with Sam Azarian, Jr., for the municipal parking lot located on Marquette Street just North of State Street, with the following stipulations:

- A. The term of the lease shall be for 20 years beginning January 1, 2008.
- B. Either party may cancel this lease agreement after providing a 6 month written notice.
- C. The Lessee shall provide all day-to-day maintenance including snow removal, litter control and grass cutting.
- D. The rental rate shall be equivalent to \$1.00 per year plus the stormwater fee which is assigned to this property.
- E. Any capital improvements which are to be made to this property shall first be approved by the City of Racine.
- F. If the City cancels the lease agreement prior to the 20 year term, the City agrees to pay to the lessee the cost of any capital improvements minus depreciation.
- G. If the lease goes full term, the City shall not be responsible to pay any compensation to the lessee for any capital improvements.

Fiscal Note: This lease will relieve the City of Racine of maintenance responsibilities for this parking lot and will result in yearly revenues to the Parking System equal to the stormwater fee plus \$1.00.

Rick informed the Committee of the history of the disposition of the property from the original discussions and a policy was created for the sale of properties. It was then noted by Ald. Hart that a lease agreement would be more appropriate in this instance. Rick noted the proper term of the lease could be 20 years with an escape clause for the City for a six month period, in which they could request use of the property back. The agreement would have to notify the City if the lessee was going to make any improvements and wanted any compensation for said improvements if the property reverted back to the City. It was agreed to lease the property for \$1 per year, plus the cost of stormwater fees for that parcel. Steve Tajnai appeared before the Committee and indicated that would be acceptable.

On a motion by Karas, seconded by DeHahn, the Committee approved the lease and authorized the Mayor and City Clerk to enter into the agreement.

4. <u>07-0404</u>

Subject: Communication from the Alderman of the 2nd District wishing to discuss the rehabilitation of the brick pavement on College Avenue from DeKoven Avenue to 14th Street.

Recommendation of the Public Works and Services Committee on 9-25-07: The policy for reconstruction of streets with brick/concrete pavers be approved. The following requirements will be used for the construction or reconstruction of streets with brick/concrete pavers:

A. Street must be in a recognized Historic District.

- B. Street is classified as a local street.
- C. Street must have been paved with paver bricks at some point in its history.
- D. That the residents abutting the street agree to pay the equivalent of the assessment charge for construction with concrete.
- E. That the city utilizes sewer revenue dollars to cover the difference in cost between the total cost of the project and the amount owed by assessments.

Fiscal Note: This policy will allow for the rehabilitation of brick streets, such as College Avenue, with the abutting residents paying their fair share without placing a burden upon the remaining city taxpayers. This policy will also allow the means to expanded the number of streets paved with pavers which will be an asset to those neighborhoods helping to maintain or increase property values.

5. <u>07-1103</u>

Subject: Communication from the Alderman of the 9th District wishing to discuss the reconfiguration of the intersection of Grange Avenue, Washington Avenue and Wright Avenue.

Recommendation: Defer

Ald. Karas indicated there was consensus of the businesses near the intersection to close the area up. There is a need for additional parking and to eliminate some of the confusion at the intersection. Rick noted, since the intersection involves a connecting highway, the appropriate action would be to have a consultant design any modifications to meet the Wisconsin DOT requirements. John suggested contacting the consulting firm of Clark Dietz to get an estimate for alternative geometries for the intersection and perhaps another estimate for design services to see how much it would cost to fund the engineering work. Rick noted, once the estimates were in, the City, if they elected to move forward, could appropriate the funds in the budget to hire a designer to proceed with the improvement project. Rick requested the item be deferred until January while the Assistant Commissioner/Engineering contacts Clark Dietz for some estimates for the work.

On a motion by Karas, seconded by DeHahn, the Committee deferred the item.

Alderman Anderson asked a study be conducted to determine if there is adequate lighting at this location. Rooney requested the item be deferred so the technicians can assess the situation and report back to the Committee.

Fiscal Note: Not applicable at this time.

Rick noted sanitary sewers existed along the back property lines in the vicinity of the three streets. These sewers were installed, but not easement has ever been recorded for the sanitary sewers. Easements were drawn up in 1975, however, no signatures by property owners were ever received and they were never recorded at the Register of Deeds. The need for the easements was prompted by a request to do a garage extension, and that's how it came to the attention of the Building Department that a sanitary sewer existed in that location. Rick asked the Committee to authorize the City Attorney to take the necessary steps to acquire easements for the 29 properties affected by the sanitary sewers.

Subject: Direct Referral. Communication from the Assistant Commissioner of Public Works/Engineering submitting an easement for traffic signal and street lighting at the intersection of 18th Street and S. Memorial Drive.

Recommendation: The City Attorney be authorized and directed to take the necessary steps to acquire an easement from Modine Manufacturing, Inc., for the future installation of traffic signals at the intersection of 18th Street and S. Memorial Drive.

Fiscal Note: Not applicable at this time.

John noted an easement is needed for future traffic signal and street lighting at the intersection of 18th Street and S. Memorial Drive. The easement is needed on the Modine property, which is the entrance to their facility off S. Memorial Drive. He noted this entrance is located across from the new 18th Street built for the Southside Industrial Park. The future traffic signal conduits were put in, in the event traffic generation from the park created a demand for signals. He noted, however, during construction, there was no place to put the conduit in the existing r-o-w and the easement is required. Modine approved the installation prior to the easement being filed. He asked the City Attorney be authorized to take the necessary steps to acquire the easement.

On a motion by Karas, seconded by DeHahn, the Committee approved the request.

John presented the amendment and noted it is in the amount of \$44,706.29 with the City's share being 20% or \$8,941.26. The amendment is for additional traffic signal work, temporary traffic signal work during construction and temporary street lighting design for construction, additional real estate and utility coordination work with WE Energies. Rick noted the cost of the amendment is negotiated by the Wisconsin DOT Local Program Manager.

On a motion by Karas, seconded by DeHahn, the Committee approved the amendment and authorized the Mayor and City Clerk to enter into the agreement.

Rick noted the Village of Mt. Pleasant has authorized sidewalk extensions on their portion of Oakes Road north of 16th Street and south of 21st Street. The sidewalk extensions would be taken on by Mt. Pleasant and they have requested the City install sidewalks on our portion of the Oakes Road project as well. Sidewalks are an assessable cost and a public hearing would have to be held. If this was to move forward, he would notify the Committee if a preliminary resolution would have to be submitted for a public hearing at that time. This is informational only and no action is needed at this time.
