#### 5. <u>11-7012</u>

**Subject:** Communication from the Transit and Parking System Manager requesting the review of public comments from the October 20, 2011 public hearing. (Resolution No. 11-2806)

**Recommendation of the Transit and Parking Commission on 10-26-11:** The Transit and Parking Commission go on record favoring the maintenance of Sunday service as the top priority for reinstating proposed BUS service cuts with a potential increase of the cash fare

up to \$2.00 and the monthly pass up to \$66.00 as an alternative source of new funding if no other potential revenue sources can be identified.

**Fiscal Note:** The estimated new money required to not eliminate all Sunday service as proposed is \$250,000. The estimated new revenue generated by a 33% fare increase is estimated to be \$220,000 after a projected decrease in ridership of 15% is considered. No additional City funding for BUS operations is anticipated.

A report of comments received at the October 20, 2011 BUS service reduction Public Hearing was reviewed along with potential options. Commission members mirrored public concerns about Sunday service cuts and late night service cuts that would reduce access to jobs. Projections for potential new revenue from fare increases were not high enough to replace both sets of proposed cuts and Commissioners opted for a recommendation to provide Sunday service in the 2012 budget with the recommendation to raise fares as much as 33% to provide the required funding if no other source of new funds can be identified.

Motion made by Kowbel, seconded by DeHahn favoring the maintenance of Sunday service as the top priority for reinstating proposed BUS service cuts with a potential increase of cash fare up to \$2.00 and the monthly pass up to \$66.00 as an alternative source of new funding if no other potential revenue sources can be identified. Passed unanimously.
