In summary, she stated that the financial statements present fair, in all material respects, the financial position of the Racine Wastewater Utility as of December 31, 2007 and 2006, and the results of its operations and cash flows for the years then ended in conformity with generally accepted accounting principles. It was also stated that a Management letter will be forthcoming.

**Subject:** Proposal from Earth Tech for 2008 Root River Interceptor Investigation, FEMA Sewer CCTV and Manhole Investigation

# **Recommendation:** Approve

The General Manager presented a proposal from Earth Tech relating to work that is necessary as a result of the record flooding in June 2008 on Root River. The work involves manhole inspection, preparation of bidding documents, inspection oversight, review of video files generated as a result of the inspection, and a final project report. This work is eligible for FEMA grant reimbursement.

Commissioner Hart made a motion, seconded by Commissioner Becker, to recommend entering into an agreement with Earth Tech in the amount not to exceed \$36,065.00 for services described above. The motion passed unanimously.

- A) The General Manager informed the Commission that the Wastewater Utility would be utilizing the services of Davis & Kuelthau, S.C. to aide them in negotiations for the upcoming labor contract with Local 2807.
- B) The General Manager reminded Commissioners to contact Nancy Sanders if they are interested in attending WEFTEC 2008 in Chicago.
- C) The General Manager noted that there would be a "true-up" for Wastewater rates for 2009. He said that the Wastewater Utility expended less money in 2007 than budgeted, which will offset budget increases in the 2009 rate calculations.
