This is something that needs to be reviewed by Human Resources and will need to be voted on by Finance & Personnel and then go to the Common Council. Cainion explained that currently there is an optional casual day or floating holiday as a means of allowing interested staff to get a paid day off. The AAHRC can put forth a recommendation to recognize Juneteenth as a paid holiday for city staff.
