The following report reflects calls for service regarding Licensed Premises which have been submitted to Investigator Jody Spiegelhoff.

VIPERS 501 HIGH STREET

On 12-09-06 Officers were working part time at Vipers. A black male attempted to enter the bar with an ID for ROBERT HOLLAND. The bouncers refused to let him in because the ID did not look like the person trying to enter the bar. The Officer stopped the individual and positively identified him as ERIC WHITE, DOB 06-01-87. WHITE was issued a UMCC for producing a false ID card. There were also two females who attempted to enter the bar using ID cards that didn't belong to them. They were denied entry and left the area prior to police being able to stop them. No arrests.

FALSE ID (UMCC)

TOTAL 24 930 WASHINGTON AVE

On 12-11-06 NAVPREEH MANHANI reported to police that a 16-17 year old black male was unwanted in Total 24 and that the black male pushed MANHANI several times. MANHANI reported to police that he protected himself by beating up the black male, forcing him to the ground. The black male then pulled out a silver handgun and aimed it at MANHANI. No shots were fired, and the black male suspect left, but then returned after about 10 minutes. MANHANI stated that the store was full of customers and the black male waved the silver gun around in the air, causing all the customers to flee the store. MANHANI locked the doors and told his wife to push the hold up alarm, but she pushed the button to unlock the doors instead and the black male fled the store. MANHANI advised that he didn't call police right away because he was told if he calls police too much, he'll get into trouble. No citations or arrests.

JOEY'S 1862 TAYLOR AVE

On 12-16-06 police responded to a fight outside of Joey's that began inside the bar. Upon police arrival, the bartender, DAVID MITCHELL, stated the two white females who were fighting were told to leave and they complied. The two females attempted to re-enter the bar a short time later and the police were called again. The two females left prior to police arrival. No citations or arrests.



MICHIGAN PUB 1300 MICHIGAN BLVD

On 12-17-06 at about 1:44 am, an argument began inside the Michigan Pub between JEFFERY

ANTON and another white male possibly named JAMES BROSKY. The two were asked to leave
the bar, which they did. They continued to argue outside which led to BROSKY punching ANTON
causing him to receive five stitches across the bridge of his nose. ANTON stated he did not report
the incident right away to police because he wasn't sure of the offender's name. A contact letter
was sent to ANTON reference his case. It has not been assigned for follow up at this time. No
citations or arrests.

TGB 1814 TAYLOR AVE

On 12-17-06 JEREMY FREEMAN was assaulted by at least one and possibly three unknown black male while inside the bar. According to witnesses, FREEMAN was cornered by the multiple suspects and hit in the head with a beer bottle during the assault. One witness did give a nickname for one of the offenders and advised that the offender can be identified via a photo line up. FREEMAN advised officers that he does not know the suspects. No other information is available at this time.

On 12-26-06 there were three (3) white females (DEBBIE JONES, CORRINA YARBROUGH and TONI TOBIAS) assaulted outside the bar by 2-3 black male suspects. None of the three female victims can ID who assaulted them. During the assault, YARBROUGH had one tooth knocked out and two black eyes, JONES had 7 teeth knocked out and TOBIAS had a jaw injury. All three victims were knocked unconscious by the offenders. Information was developed during the investigation that one of the bartenders, CRYSTAL ZAEHLER, knows two of the suspects who assaulted the three victims outside the bar. ZAEHLER is avoiding assisting with the investigation thus far. The bar's owner, CHAD LONDRE, advised INV. B. SPIEGELHOFF that he accidentally taped over the surveillance video from that evening. INV. B. SPIEGELHOFF is assigned this case, which is currently open. No suspect names are being released at this time. No citations or arrest. See reports.

BLUE ROCK 306 6TH STREET

On 12-17-06 at 3:25 am, Officers observed an unusual amount of cars parked outside the Blue Rock Tavern, therefore a tavern check was initiated by the Officers. The Officers did find seven people inside, on the upper level, drinking alcohol, shooting pool and playing darts. The owner, MARK R. THOMAS, stated that all but two of the people inside the bar were employees. THOMAS was cited for a closing hour's violation. On 12-06-06, one of the Officers on scene observed people on the premise until the last person was seen leaving the bar at 4:45 am.

CLOSING HOURS VIOLATION

MR. KOOLS 1330 WASHINGTON AVE

On 12-24-06 Officers responded to Mr. Kools for a fight report. Upon Officers arrival, there was no active fight, but there were numerous vehicles in the street and about fifty people on the west sidewalk in the 1300 block of Washington Avenue. After the cars dispersed, Officers located hair in the street. No victim's or suspects could be identified. No citations or arrests.

VRC 3701 DURAND AVE

On 12-26-06 there was a private party at the VRC bar. Two individuals attempted to "crash" the party, according to ANTHONY and JAMES MARINO, and then refused to leave. The two individuals then tried to attack ANTHONY; however, they were stopped by ANTHONY and others inside the bar. The two individuals were verbally abusive towards the responding Officers and uncooperative. The MARINO'S just wanted them to leave. No citations or arrests.

On 12-31-06 at 12:53 am, officers responded to VRC for a civil problem over a pool game. Officers spoke with all the parties involved and nobody wanted anything done. The bar closed down early to avoid any other problems that night. Later at 4:06 am, police received a call from St. Mary's Hospital for an assault report. The Officer met with MARK FREITAG, who was one of the individuals officers spoke with earlier at VRC. FREITAG stated he got into an argument with an unknown white male about 6'03" and 260 pounds, over who was next in line for the pool table. FREITAG stated that the unknown white male pushed him outside the bar, and then punched him in the head with a fist. FREITAG then fell to the ground and was kicked by 4 or 5 different individuals. FREITAG stated he believes the bouncers took part in assaulting him, however, could not give any clothing descriptions of anyone involved. FREITAG also believed that one of bouncers is the initial aggressor's son; however, it is unknown why he believes that. FREITAG reported this incident as an assault after he woke up at about 3:30 am in extreme pain. FREITAG'S brother then drove him to the hospital for treatment. No citations or arrests.

MIKE'S WINNER'S CIRCLE 1403 SUPERIOR ST

On 12-29-06 Gang Unit Officers were working in the area of the Winner's Circle and received information from a confidential informant that there were active drug sales going on inside the bar. The C.I. further informed the Gang Officers of a specific individual who just purchased drugs and left the bar. That individual was stopped, which led to the arrest of the individual who was selling the drugs inside the bar. No names are being released at this time.

THE DRINK 961 MARTIN LUTHER KING DRIVE

On 12-31-06 at 2:35 am, Officers were sent to The Drink for an unwanted party refusing to leave and causing problems. Upon Officer's arrival, they observed about 20 people leaving the bar. Then they observed two people who were standing outside, re-enter the bar, and then close and lock the door upon seeing police arrive. Officers also noticed about 15-20 vehicles still parked outside the bar. Since the call for assistance came from inside the bar, Officers knocked on the door, however did not receive a response right away. Officers kept knocking, numerous times, until someone from inside the bar said "just a minute." One of the Officers had prior knowledge that The Drink hides people in the basement after closing hours to keep drinking. The owner, MICHAEL MISNA, came to door and advised that no one was left in the bar except employees who were cleaning. One of the Officers reported that Friday night, 12-29-06, she observed people leaving the bar at 3:00 am. Officers entered and began escorting about 13 people, who were still drinking alcohol, out of the basement. MISNA was advised about lying to the police department and issued a citation.
