NARRATIVE

On 04/11/2026 at approximately 2055hrs, I, Officer Bailey, was working for the Racine Police Department in full uniform, body camera worn, and operating R19. I was dispatched to the area of Meet N Greetz for approximately 8-10 females and males arguing, pushing and shoving in front of the business.

Upon arrival, I did not observe any of this activity occurring. I did observe a male/black leaving the area while holding a clear plastic cup containing a pink in color beverage. I spoke with a female/black who was standing in front of Meet N Greetz. The female informed Officer's none of the activity was related to the business. It should be noted that this female identified herself as the owner of Meet N Greetz. While speaking with the female, I observed multiple individuals inside of the business holding onto the same plastic cup the male was holding upon our arrival. I also observed a five-gallon jug in the far north corner that contained additional beverages. When I asked the female about intoxicating beverages, she denied and became very uncooperative. The female then entered the business and closed the door behind her preventing Officer's from entering.

This is an informational report documenting what observations I made during this call for service. At this time, it is unaware what type of beverages the individuals were consuming.
