RE: Adams Outdoor Sign – 1301 6<sup>th</sup> Street

Dear Brian,

It was a pleasure meeting with you last week to discuss the items that need to be resolved with the City of Racine regarding our beautification efforts related to our sign inventory.

In our meeting, you had asked that I send a proposal to you for the placement of our sign at 1301 6<sup>th</sup> Street.

You may recall that Adams had proposed to relocate our sign entirely on City property at this location, and the City has vacated a portion of right of way to accommodate for the placement of the sign.

Because Adams will have substantial costs with a new structure and landscaping at the site, we are looking for a ten year lease term. We are proposing an annual lease rent of \$2,000.00 per year, payable annually in advance. In addition, Adams will increase the annual rent in accordance with the previous year's increase in the Consumer Price Index.

I assume the City will want to utilize its lease form for this purpose, so I have not included an Adams lease agreement with this letter. I have included, however, previously submitted materials regarding this site.

Although we're disappointed that we couldn't come to an agreement on the property exchange portion of our beautification plan, we're still very excited about the remaining portion of our plan. I think it will go a very long way in improving the quality and appearance of our inventory.

I look forward to hearing from you regarding the rebuilding of this sign.
