Presentation by Melissa Warner: River Park Signage

Melissa Warner presented a PowerPoint slideshow and discussed the need for river parks signage. She stated people value what they know and they need to know the parks by name, where they are and where the amenities are such as canoe launches & fishing. There are 10 parks along the river which include Colonial, Lincoln, Brose, Lee, Island, Riverside, Cedar Bend, Clayton, Barbee, and the REC. There are not signs posted off of main roads to show where these parks are.

Schaal inquired if the signs had been priced out. Warner answered no. They could possibly be done in house, though a decision needs to be made on what type, what size, and so forth for each park. Schaal also inquired if it would possible to raise money to aide in the purchasing of the signs. Perhaps having an independent person or group organize a run.
