Edward Fahnrich a representative of Timer's appeared and explained to the committee that Timers has been in operation for over 35 years and have always had to competed with grocery stores and wanted the committee to know that he would like the same opportunities that some of his neighboring businesses have.

Alderman Wisneski submitted what he felt would be some proposed changes if we allowed Class A establishments to hold wine sampling events

Proposed Modifications to Ord. 6-97

If all of the following are agreed to and met, a Class-A facility in the City of Racine shall be allowed to provide samples of wine in accordance with State laws.

- 1. Number of employees: must have at least three (3) employees working (not including the wine representative) at the time of the sampling.
- 2. Facility must be at least 3000 square feet in size.
- 3. Facility must be able to demonstrate by providing last year's sales data that at least 25% of total alcohol sales are wine.

This exemption may be applied for at any time and lasts until the end of the accompanying annual liquor license.

There shall be a fee of \$50 to apply for this exemption.

There was some other points brought up and discussed such as to where the sampling would take place in the structure and history of establishment. It was also noted that the City Attorney would need to find out if we were able to include these exceptions. Alderman Mozol stated he wanted to know how many establishments would be possibly allowed. He will generate a demographic map.

Motion was made by Alderman Mozol and seconded by Alderman Wisneski to defer and gather more information and for the City to determine if exceptions would even be allowed. Motion passed by the following voice vote:
