Saturday, September 27, 2025

Rogers - Officers were dispatched in reference to an unwanted party. License premise was completed with no violations observed. **25-045030**

Doobies Beer Joint - Officers were dispatch in reference to noise violation. A vehicle was parked illegally with loud music. The party was advised and vehicle was parked. Officers conducted a license premise check and no violations observed. **25-045032**
