Mr. Molbeck.

The following proposed field changes were made by CW Purpero, with respect to the Zoo Beach Access and Shore Protection Project. SmithGroup has reviewed the provided estimated costs and change details, and below is a discussion of our review and recommendations.

- In-Water Groin Removal: The city previously approved a change order for \$44,000 to remove upland portions of two derelict groin structures along the beach. This addition would remove and dispose of the last section of each groin located in the waters of Lake Michigan. The total cost for this work is estimated as \$15,400, including labor and disposal, and will be billed Lump Sum.
- Diver Assistance for In-Water Groin Removal: CWP will utilize divers to ensure complete
 removal of debris related to the in-water groin removal. This will help ensure that there is not a
 hazard to public safety from concrete or steel reinforcement from the historic groins. The work
 will be billed at a day rate which is estimated to be \$9,970 per day, with one day of labor required
 to perform the work.
- Stair Support Wall: A support wall on the lakeside of the concrete stairs will be incorporated to
 help with construction and provide a barrier to reduce erosion under and loss of sand under the
 stairs. The total cost for this work is estimated as \$2575, including labor and materials, and will
 be billed Lump Sum.
- Riprap Flume: To combat erosion along the bluff slope, due to runoff from the bike path, a riprap
 flume will be placed to provide protection from surface erosion while also reducing the velocity of
 runoff down the hill side. The total cost estimate for this work is \$2,648, including labor and
 materials, and will be billed Lump Sum.
- Anti-Graffiti Paint: To help prevent graffiti vandalism along the vertical wall next to the concrete steps, an anti-graffiti paint coating would be applied. The total cost estimate for labor and materials for this work is \$1,250 and would be billed Lump Sum. Any leftover materials would be provided to the city for ongoing maintenance.
- Chain Link Fencing: Approximately sixty feet of chain link fence would be installed along the slope side of the path where the slope is steepest and presents a potential hazard to path users. The total cost for this work, including labor and materials is estimated at \$4,200 and would be billed at a per linear foot price of \$70.
- Full Depth Asphalt Pavement: A portion of the asphalt pavement, which previously was intended to only receive an overlay, was significantly impacted during construction and would require full depth replacement instead. This item would include removal and disposal of existing asphalt and reconstruction of the base and asphalt pavement. The total cost for this work, including labor, disposal, and materials is estimated as \$30,110 and will be billed Lump Sum.

• Cost Reduction For Vegetation Maintenance Contracting Directly With City: NLI will directly contract the required 3 years of vegetation maintenance with the City. The estimated cost was \$4,500 per year, and thus a cost reduction \$13,500 will be applied to the overall project cost.

These change orders have been discussed with the city and SmithGroup agrees with the authorization of the change orders, as proposed by CWP. The total price of Change Order #2 is \$52,653.

Racine Zoo Pathway Project

Management and Monitoring

All naturalized growing spaces throughout the footprint of this project shall be managed and monitored throughout the entire 2023 growing season. Monitoring shall consist of periodic visits during the growing season to evaluate the site's vegetative state and determine what methods of management may need to be performed. Management recommendations shall focus on the control of noxious plant species that may pose a threat to the establishment of desirable native vegetation.

Management shall consist of selective cutting, mowing and spot herbicide application of invasive plant species when necessary. Invasive plants would include, but are not limited to, Phalaris arundinacea (reed canary grass), Lythrum salicaria (purple loosestrife), Cirsium arvense (Canada thistle), Salix sp (willow), Cirsium vulgare (bull thistle), Melilotus sp (white and yellow sweet clover), Dipsacus sylvestris (teasel), Arctium minus (burdock) and all invasive woody species such as willow, honeysuckle, and buckthorn. All areas shall be mowed at the completion of 2023 growing season to mimic natural fire and thatch up dormant plant matter and set back invasive woody species.
