Rehrig Pacific Company had a 3rd party vendor providing the tracking system, which failed operation in January and still has not been repaired by the 3rd party. Rehrig now has an internal tracking system that can be maintained internally. We can get the new system for the reduced cost of \$38,600 that includes a \$1,400 reduction.

Funding for this purchase is available in Org-Object 22140-52100, Recycling-Professional Services. I recommend that the Purchasing Agent be granted permission to negotiate the acquisition of these devices and the software upgrade.

There will be no monthly increase in the cost of the existing agreement with Rehrig Pacific Company regarding the Recycle Cart System.
