Criteria

A. Public Health-oriented understanding of community safety.

Women's Resource Center of Racine, Inc. (WRC)is proposing Legal Advocacy and legal support for victims/survivors and potential victims of domestic violence. WRC believes that domestic violence is a public health and community concern. In line with public health approaches to community violence, effective care for victims and survivors of domestic violence is multidisciplinary. The focus of WRC's work and this proposal:

 Serves those individuals at highest risk for experiencing community and interpersonal violence.

Victims and survivors of domestic violence remain at high risk for experiencing subsequent episodes of violence unless they make changes to their own lives and are lack the necessary support and guidance to do so. Survivors face numerous barriers to breaking the cycle of violence for themselves and their children and unless removed, survivors may return to abusers or enter into other violent relationships to face further revictimization. Legal intervention is frequently required.

The proposed services are *informed by and respond to the impact of trauma on individuals*and the broader community in historically underinvested communities.

Legal services are trauma sensitive and culturally appropriate. Domestic violence results in trauma, with ongoing abuse imposing trauma for extended periods of time. During the past calendar year WRC provided shelter and services to 350+ individuals. 27% of outreach participants were black/African American, 26% were white, 10% were more than one race, 7% were Hispanic, 1.5% were Native American, <1% were of Asian descent, and 32% were unknown or did not report racial information. All the shelter residents reported income that placed them below federal poverty levels. Individuals of color, and those experiencing poverty are disproportionately over-represented at WRC. WRC serves Racine County's most marginalized individuals.

 The purpose of all services and programs offered by WRC are to promote healing and resiliency in the targeted population.

After ensuring safety, the primary focus of services at WRC is to promote healing and resiliency. Addressing legal situations is one step on the path to healing. Empowerment fosters resiliency, and resiliency permits a future free from violence.

 Through information and education, promote community ownership of safety outcomes in residents and neighborhoods.

A primary function of WRC is to provide community education and information about the insidious and dangerous nature of domestic violence.

B. Community Safety Priorities

• The focus of this proposal is **Intimate Partner Violence.**

Interpersonal abuse has a devastating impact on families and the community. Domestic violence intervention and prevention is a matter of life and death.

 This proposal also explores the disproportionate impact of violence on some groups and communities.

The target community will be victims/survivors of domestic violence, sexual assault, human trafficking or other interpersonal violence who are in need of consultation regarding legal matters. The majority of these individuals will be low-income women, and a significant percentage will be individuals of color. Domestic abuse impacts women and especially low-income women disproportionately due to a variety of circumstances. Thesem women lack the resources and access to services available to other populations.

Qualifications and Experience 20

Women's Resource Center of Racine, Inc. (WRC) is the only dedicated full-spectrum provider of emergency and supportive services for victims/survivors of domestic violence in Racine County. WRC also offers shelter to survivors of sexual assault (in collaboration with BeLeaf) and human trafficking (in collaboration with Fight to End Exploitation).

Women's Resource Center of Racine is an active participant in the Racine Violent

Crime Reduction Initiative. WRC serves as the voice of victims and survivors in this group and
provides the group with domestic violence education and local statistics and demographics.

Through this collaboration, WRC also offers its SafeStart, teen dating violence prevention

program in local Community Oriented Policing Houses. Intervention and education at young ages is key to breaking the cycle of violence.

Women's Resource Center was formed in 1977 by a group of concerned citizens who recognized that domestic violence was dangerous, and women (then the primary focus) needed safety and shelter if they were to escape the throes of abuse. WRC was incorporated in 1980 and has continuously provided programs, services, outreach and community awareness. Over the years, it was determined that victims of domestic violence needed much more than a safe place to stay. Advocacy was always part of the program and remains a mainstay today. WRC offers advocacy, counseling support, safety planning, housing search assistance and anything else needed to assist survivors in breaking the cycle of violence and becoming safe and independent. Victims of domestic violence often find themselves with legal entanglements and/or the need to pursue legal interventions to ensure the future safety of themselves and their children. Obtaining restraining orders is often a priority when individuals leave or are attempting to leave an abusive situation. Child support, child custody, separation/divorce, eviction, small claims court, driver license reinstatement, and other legally related situations may present barriers to developing safety and stability. Since the 1980s WRC has always provided some form of legal advocacy and is at a position where the need for additional enhanced services is required. WRC offers services to any member of the community who is experiencing interpersonal abuse, even those not residing in shelter.

Respondent Approach to Providing Services 20

To ensure that victims and survivors of intimate violence receive legal advocacy and assistance in seeking legal services, WRC employs individuals knowledgeable of the legal procedures and systems encountered by potential victims and survivors of domestic violence. Services are available to WRC residents, by referral from other providers, and by self-referral. Funding will support a Legal Advocate and a Legal Specialist between June 1, 2024, and December 31, 2024. Current resources for legal advocacy are inadequate.

Victims and survivors of domestic or other interpersonal violence face many barriers to rising above the trauma inflicted upon them and find it difficult to traverse the legal system when necessary. Impoverished women, and women of color are overrepresented in domestic violence shelters and programs. They are least likely to trust the legal system, and may need information, support and encouragement to take necessary and important steps. Addressing legal concerns opens the door to continued healing and building stable, safe and independent lives. This trauma sensitive, survivor driven project promotes breaking the cycle of violence, sparing entire families from revictimization and devastation.

This program ensures that those already impacted and devastated by domestic violence, or its potential victims have access to legal services that protect them from further revictimization and violence. Two mainstays of providing care for survivors of domestic violence are trauma informed practices and Motivational Interviewing. Both approaches are evidence-based and are known to be effective in working with survivors of violence because they take into consideration the lived experiences of the victims, prevent re-traumatization, and put the client at the center of the decisions being made to secure their future safety. Legal advocacy

can serve as a buffer between the "black and white" nature of the law and the raw emotions of victims.

The Legal Advocate and Legal Specialist assist survivors with their legal needs. The purpose of this proposal is to provide expanded more robust services to WRC residents and to other members of the community. The legal advocacy program assists survivors with paperwork, refers them for formal legal services, accompanies them to court, and explains the legal process and outcomes. Obtaining restraining orders can save lives, obtaining deserved child support and benefits supports children and is life-sustaining. Divorcing and resolving custody disputes clears the path for future stability. Having driver licenses reinstated improves chances for employment and decreases the possibility of additional legal action. Addressing legal matters alleviates stress. Testifying against an abuser is empowering. Using the legal system to their advantage puts survivors in control of their lives.

The legal services team will be instrumental in reestablishing the Family Violence Task Force. It was important in making positive changes in the approach to domestic violence in the community.

Services will be available to those residing at WRC, those who contact WRC specifically for Legal Advocacy, to those residing at Bethany Apartments, those receiving services from Fight to End Exploitation, SAFE Haven of Racine, Transitional Living Center or those who have experienced sexual assault.

Respondent description of how funds will be budgeted for use 15

WRC anticipates serving a minimum of 150 survivors of domestic violence during the six-month award period. WRC is requesting \$41,403.50 to support Legal Advocacy Services. We are

requesting \$21,840 dollars in salary for the Legal Advocate for the six-month award period. The Legal Advocate will work 30 hours per week and will be paid \$28.00 per hour. \$3,276. dollars will pay taxes and benefits for the position. The Legal Specialist will assist the Legal Advocate working 20 hours per week for the grant period at a rate of \$22.00 per hour for a total of \$11,440.00. \$1,716.00 will pay taxes and benefits for the position. Cell phone services for these positions will cost \$320 for the six-month period. We anticipate that there will be \$300 expended on miscellaneous supplies. The position will require travel to court, to clients and to other agencies and we have budgeted \$127.50 to cover 250 miles at \$.51 each. We are requesting 3 hours a week of supervision for this position at \$30.00 per hour or \$2,340 for six months for a total of \$41,403.50

Prior Experience and familiarity of required services 5

Women's Resource Center has vast experience is implementing and administering grant awards of this nature. Since the 1980's WRC has received ongoing State assistance from the Department of Children and families to operate its emergency shelter and victim services. It is the current recipient of Wisconsin Department of Justice funding to support a Holistic Healing program and services. WRC is also a long-time recipient of City Emergency Solutions grant funding and State homelessness funding awards. Additionally, WRC has received private funding from foundations (Racine Community Foundation, Otto Bremer Trust, Webb Family Fund, etc.) corporate funders and the United Way of Racine County.

If awarded funding for this proposal, WRC recognizes its responsibilities and obligations. WRC will implement and carry out programming, will submit monthly progress and financial reports and comply with all WCSF requirements.

This program will be an enhancement and expansion of already existing legal advocacy services. The funds presently available hinder the number of victims and survivors that can be served. WRC has been providing legal advocacy services in some capacity since the 1980s. This proposal will fund a Legal Advocate and a Legal Specialist. Thes positions coordinate legal services for victims and survivors. Katie Bolander, J.D. presently serves in the capacity of Legal Advocate. Current funding is ending and provides for only limited access to services. WRC's current Legal Advocate has been providing legal advocacy in some capacity since her graduation from law school. The current Executive Director provided legal advocacy services in the past, and WRC's CFO is a licensed attorney who worked in the criminal, juvenile and family courts, and is available to advise the program.

WRC is fortunate to have someone with legal education in the position although she is not a licensed attorney. The Legal Advocate works closely with Legal Action of Wisconsin personnel to ensure that documents are completed and that survivors are adequately prepared to appear in court, regardless of the reason. The Legal Advocate also serves as a liaison to private attorneys, the District Attorney's Office, Victim Witness Assistance Program and law enforcement agencies. In addition to assisting in the preparation of restraining orders, aiding survivors with child support, child custody and other legal concerns, the Legal Advocate informs and educates survivors about the legal justice system, what they can expect from their involvement in legal proceedings Additionally, the Legal Advocate will provide

training to agency staff and to other community members regarding the legal aspects of domestic violence and will coordinate the Racine County Family Violence Coalition. This position reports to the Executive Director.

Knowledge of the City of Racine 5

Having provided services in the city of Racine for 47 years, WRC knows the city and its resources well. WRC has numerous community partners through its relationship and activity with the local Continuum of Care, and its member partners who serve vulnerable populations. This proposal provides additional opportunities for partnership regarding Legal Advocacy services. Bethany Apartments, Fight to End Exploitation, SAFE Haven of Racine, Transitional Living Center, BeLeaf will all be invited to refer clients for Legal Advocacy. It is likely that HOPES Center, Racine Vocational Ministry and others may have clients appropriate for services. Efforts will be made to partner with the Marquette Law School, to provide interns and support.
