Submitted for your review and approval is Amendment No. 1 to Contract 19-14 (K4-019), Professional Services-City Hall Annex Fire Alarm, Strang, Inc., consultant.

The contractor and his supplier submitted a change order in the amount of \$19,870 to provide additional cabling and detectors to comply with the NFPA Requirements. We had Strang review the change order request and it was determined the initial design did comply with the NFPA Requirements which resulted in the denial of the \$19,870 change order. This amendment covers the additional site and plan reviews needed to make this determination.

This Amendment is in the amount of \$4,270.00 with funding available in Org-Object 45040-57200, Annex-Upgrade Fire Alarm (994.200.5020).

As you requested, following is a summary of the costs for our services to date:

Construction documents including site survey and preliminary meetings	\$11,905.00
Bidding period including pre-bid meeting at site with bidding contractors	\$1,920.00
Construction meetings (two) at site and time in office to verify code compliance and drawing accuracy. This was required due to claims for extras by contractor	\$5,605.00
Shop drawing review	\$240.00
Total	\$19,670.00
Original "Not To Exceed" fee	\$19,000.00
Additional amount to original fee	\$670.00
Estimated cost for two (2) additional trips to site	\$3,600.00
Request for additional fee, hourly plus expenses not to exceed	\$4,270.00

As described above, the main reason we exceeded our original fee was due to the change orders of approximately \$20,000 requested by the contractor which we determined not to be valid. This totaled \$5,605.00 in additional expense. We are requesting that our original contract amount of \$19,000.00 be amended to increase the maximum amount by \$4,270.00 for a total of \$23,270.00.
