The General Manager noted that the Utility requests to amend Sec. 98-149 (e) of the Municipal Code of the City of Racine which relates to sewer use charges and invoicing. He recommends deleting the words "city treasurer's office, city hall;" in the fourth sentence of the paragraph. He also noted that he recommends the following to be added to Sec. 98-149 (f): "The Utility shall compute charges for industrial customers determined to potentially discharge wastewater in concentrations in excess of "normal strength" or whose wastewater discharge flows may be substantial resulting in pollutant mass at such levels that Class II charges exceed Class I charges after applying approved Class I and Class II rates. The Utility shall charge the greater of the two calculated charges".

A motion was made by John Dickert, seconded by Secretary Thomas Bunker, that this be Recommended For Adoption. The motion PASSED by a Voice Vote.
