Subject: Calls to Licensed Premises from 1/10/2026 to 1/25/2026 (Meeting 1/28/2026)

Saturday, January 10, 2026

Doobies - 3701 Durand Ave - Officers self dispatch to provide extra attention. No violations were observed and no contact with the bar was made. **26-001529**

Honors Racine - 1330 Washington Ave - Officers were dispatch in reference to a fight between a couple. Parties left prior to police arrival. A license premise report was completed and no violations observed. **26-001536**

Sunday, January 11, 2026

Doobies - 3701 Durand Ave - Officers completed a building check and business appeared to be secured. **26-001692**

Monday, January 12, 2026

The Blue - 835 Washington Ave - Officers were dispatched in reference to shots fired. Officers located a spent casing in the parking lot just next to the blue. surveillance video showed a party firing a round while in the parking lot. A license premise report was completed. **26-001983**
