## Board of Health Meeting May 11, 2010

## **Highlights:**

- Staff coordinated and participated in the Racine County Free Medication Drop Off held at the City of Racine household hazardous waste drop off site on Saturday April17. A total of 526 cars participated. Sixty (60) pounds of controlled medications were collected and turned over to the Racine Police Department for incineration. Law enforcement personnel must take possession of all controlled medication as per Drug Enforcement Agency (DEA) regulations. Statistics for the total pounds of unwanted medication collected are not yet available. Veolia Environmental Services takes possession of and disposes of the unwanted medication. Seventeen large barrels of medication were collected. In addition to the medication we recycled plastic bags, plastic bottles, and cardboard.
- The *Kenosha/Racine Lead-Free Communities Partnership* has completed lead abatement in 3 Racine homes and 1 Kenosha home to date for the new grant that started January 2010. The program has a goal of identify and controlling lead hazards in at least 125 homes in each community (250 total). Staff is in the process of contacting individuals on the waiting list from the previous grant. The program is off to a strong start. The grant is also providing education and outreach for lead poisoning prevention.

## **Outcomes:**

- Preliminary reports identify that one hundred ten (110) children were first tested for lead poisoning; one (1) had an elevated blood lead level (>9ug/dL), or 1 percent.
- Preliminary reports identify two hundred forty-three (243) children as being tested for lead poisoning; six (6) had an elevated blood lead level (>9ug/dL), or 2.5 percent.

They suggested removing the street suffix and/or apartment numbers. There was consensus that this was not a good idea because we have streets with the same name (i.e. 6 <sup>th</sup> St. and 6 <sup>th</sup> Ave.) and there aren't enough resources to conduct lead risk assessments on large apartment complexes so an apartment number is needed to distinguish which unit was inspected. These concerns will be taken back to the committee and a follow up meeting will be scheduled.

They act aggressively toward problem properties and use several enforcement tools to gain compliance. The Mayor will follow up and assess Racine's current programs.

Breheim)	Developed a survey for potential closed dispensing sites to assess feasibility and discuss the TAR requirements with Caledonia Mount Pleasant Health Department (CMPHD)	Developed a survey tool to be administered to local business, residential facilities and churches to identify current points of contact and the number of people who work, reside or attend the facility that will likely be used as closed dispensing site to reduce the burden of population that will attend mass clinics.
