Call To Order

The meeting was called to order at 5:30 p.m.

Subject: Communication from Mayor Becker wishing to discuss returning Marquette Street and ML King Drive back to two-way streets.

Recommendation of the Traffic Commission (05-19-08): Defer

Recommendation of the Public Works and Services Committee (05-27-08): That the Mayor and City Clerk be authorized and directed to enter into a professional services agreement with Ayres Associates, Waukesha, WI, for a full traffic impact analysis to examine the feasibility of converting Marquette Street and Dr. ML King, Jr. Drive from one-way to two-way traffic for the lump sum of \$19,000.00.

Further recommend that since this item was not included in the 2008 budget, that it be referred to the Finance and Personnel Committee for appropriate funding.

Fiscal Note: Not applicable at this time.

Rick described the Mayor's request and noted he met with the Mayor and that the Mayor would prefer to proceed with the study. The Mayor may not necessarily implement the changes. Rick noted the Mayor wanted to explore all options and understood the impact on the work the City's doing with the Wisconsin Dept of Transportation on State Street and the Douglas Avenue projects. He recommended the item be approved and referred to the Finance Committee for funding.

Recommendation: That the property owner of 2706 and 2702 Chicory Road, Countryside Humane Society, Inc., located in the Village of Mt. Pleasant, be granted permission to connect to the City of Racine storm sewer system in Chicory Road with the following stipulations:

- A. That all necessary permits be appropriated.
- B. That the property owner enter into an agreement with the City of Racine that establishes the yearly payment of the annual stormwater fee as assessed to equivalent properties within the City of Racine.
- C. That the property owner be charged a \$50.00 fee to cover costs associated with filing this item with the Register of Deeds.

Fiscal Note: The property owner would pay to the Racine Stormwater Utility a yearly charge equal to that of a non-residential property which is based upon the number of equivalent run off units.

Robert Kelley appeared and described the project and noted the property is in the Village of Mt. Pleasant, however their request is to connect and be serviced by the City of Racine stormwater. The request is for drainage improvements in the parking lot. Rick noted this has been approved in the past subject to the owner of the property paying a stormwater fee.

Rick read the request and noted the usual stipulations. JJ McAuliffe appeared and thought it was a good idea to promote the anniversary of his business and also provide some money to some charities. Rick read an e-mail from the DRC opposing the event. The e-mail noted there were several other events going on at Monument Square and downtown and the DRC didn't feel the events would be complementary. Porter's, Brandt's, Moxie Child also opposed the event due to the fact that construction has closed the street for the last three months. Micah Waters was

concerned for lost revenue and didn't feel this was an indictment of McAuliffe's Pub, he simply indicated the street has been closed for too long and they needed traffic to be moving on the street again.

John noted without a permit being pulled, there is no way the Engineering's Office could have known the sidewalks had already been replaced. There is a citation and forfeiture up to \$1,000 for doing sidewalks without a permit. Kathy Hansen described the situation from her point of view. Rick suggested the City and Ms. Hansen split the cost of the two additional sidewalk squares.
