**Subject:** (Direct Referral) Review of designs submitted for an upper façade renovation at 612 Sixth Street. (DC-16)

Matt Sadowski advised the plans have been approved except for color selections. Ramona Yduante, representing the applicant, presented the final color and material selections. The stone originally approved will be replaced by grey porcelain tile. Discussion ensued about the design elements and façade appearance.

**Subject:** (Direct Referral) Request for signage at 244-266 Main Street. (DC-16)

Bob Hartman, of Hartman Designs presented the proposal. Exterior wall signage is requested in the form of aluminum cutout letters, pin mounted to the sign panel. The letters will be painted light metallic gold (sample presented). Also requested are three vinyl window graphics. No illumination is proposed.

Discussion ensued about the content and placement and appearance of the vinyl graphics. The phone number provided on the vinyl graphics is not allowed per ordinance. Following lengthy discussion, the applicants requested approval for the wall signage, and to defer action on the window signage while they explore their options.

A motion was made Alderman Coe, seconded by Commissioner Monefeldt, to approve the upper façade signage as presented, with deferral of action on the window signage. The motion PASSED by a Voice Vote.
