Some highlights: office will be at Pugh Marina, there will be a chase boat for any problems that may occur, the vehicles will have all safety equipment, they have one million dollars in insurance, they will work out of a custom tent (no electric power is needed), noise level is within the City Code, there will be two employees on duty. Discussion was held regarding the use of the vehicles and the swim area.

The payment to the City will be at the end of the season unless otherwise decided.

Wisneski moved and it was seconded by DeSonia to defer and refer to the City Attorney's office to approve language and draw up a contract. Passed unan. **Deferred** 

#### Miscellaneous

Carter said that he met with Donnie Snow and Tom Molbeck to discuss inner-city softball for youth. Working through the King Center they were able to sign up 40 youth to play softball - 38 of these youth never played softball before. Carter commended Donnie Snow and Tom Molbeck for making this happen.

Molbeck said that there are now 404 youth teams signed up for softball this year.
