RE: Extension of Juror Parking Agreement with Racine County Clerk of Courts

Dear Chairman Ganaway:

Attached is a 10-month Juror Parking Survey conducted by the County Clerk of Courts pursuant to the request of the Transit and Parking Commission at the November 2007 meeting.

The monthly costs were simply calculated with the results of the 2008 survey which indicated how many half-day and full-day jurors actually parked in metered spaces. The County and City do not know if the half-day or full-day jurors stay more or less than 4 or 8 hours, respectively, so the assumption is that they stay 4 or 8 hours. The rates of \$2.00 per half-day and \$4.00 per full-day were used with these survey numbers.

Based on the survey, the number of jurors parking at meters is comparable to 2007, so I would recommend the monthly fee remain at \$570.00/month, the 2008 rate, and that the Transit and Parking Commission approve this rate along with a 12-month extension beginning January 1, 2009 and ending December 31, 2009. A similar survey should be provided to the City by November 15, 2009 for discussion on extending the agreement past December 31, 2009. This agreement will generate \$6,840 in revenue in 2009, which is the same as the current agreement.
