

SUBJECT: Lydia Group Home

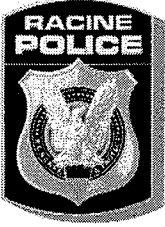

Subject: Lydia Group Home

I have a concern about the Lydia Group Home, 3131 Taylor Ave. This facility has had a significant increase in the use of police services recently, and it is causing some difficulties for third shift in particular.

Recently, we are being called to this facility for runaway juvenile reports, AWOL complaints, and to assist staff members with disobedient residents. While I understand that responding to these types of calls is our job, we have been going repeatedly for the same juveniles and the facility is doing nothing to address the problem.

After listening to several of these responses, I responded to the facility and spoke with staff member Karla Fitch to try to identify what the problem was and if a solution could be found. Ms. Fitch informed me that all of these juvenile residents are assigned to the facility through the Milwaukee County Court System and are assigned to supervision case workers in Milwaukee. These case workers have the authority to remove non-compliant residents and detain them in a secure facility, but to date, none have done so, even though they have been advised of the repeated rule infractions and constant runaway problems.

Ms. Fitch further advised that as a condition of their placement at the facility, the case workers are required to remove the resident and find alternative placement if the director of the facility requests it. Ms. Fitch advised that to date, the director, Terry Ehirobo, has not requested the removal of any resident.

Since October 1, 2007 alone, the department has responded to 17 complaints at the facility, none of which involve criminal or emergency situations, and all involving the same three juvenile girls. I have attached a report detailing these calls for service. These calls have resulted in many man hours of efforts on our part and no response or resolution by the facility.

I do not know if these calls would fit the nuisance business ordinance, but I am respectfully requesting that the director of the faculty and/or the supervising case workers be contacted about this matter and a dialogue be initiated to see what the facility is willing to do to address this drain on our resources. We on third shift are not in a position to make these contacts, and I am asking for your assistance in making these contacts.

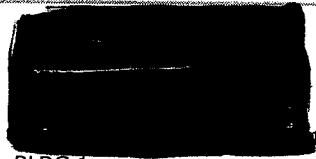
