Ald. Tate:

I looked at this on the GIS. It appears there exists about 29 feet +/- between the driveways in front of 1639 Austin Avenue. By state statute, no vehicle can park within 4 feet of a private driveway entrance and is subject to citation and forfeiture. This leaves about 21 feet +/- to park a vehicle, which is equal to or greater than a marked space at a parking meter. Is the request simply to address someone parking too close to a driveway? If it is, there exists a statute for this and RPD can be called to enforce.

Even in areas with shorter distances than this where you can't legally park between driveways, the City does not post "No Parking" or "No Parking Between Driveways" as it is covered by state statute. This is similar to not having to post "No Parking" within 10 feet of a fire hydrant as state statute covers this as well.

If this property owner wants the restriction regardless of the above, I'll get in on the 1/15/18 Traffic Commission agenda for their consideration. Let me know ASAP. Thank you.
