Call To Order

Approval of Minutes for the March 24, 2008 Meeting.

Subject: Communication from Chief of Police Wahlen requesting to use Federal law to allow qualified retired officers to carry concealed weapons.

Recommendation of the Finance & Personnel Committee on

04-07-08: Permission granted for the Chief of Police, pursuant to Federal Law Officers Safety Act of 2004 HR218, to allow retired police officers to carry concealed weapons after passing firearm qualifications and the Police Chief's approval and further recommends that the Finance Department create a separate account for the \$100 fee required from the retired officers.

Recommendation of the Public Safety and Licensing Committee on

4-7-08: That the request of Chief of Police Wahlen, to use the Federal law to allow qualified retired officers to carry concealed weapons, be approved.

Fiscal Note: There will be no cost to the City.

Lt. Jim Dobbs and Racine Police Chief Kurt Wahlen appeared. Chief Wahlen informed committee members federal law allows for retired enforcement officers to carry concealed weapons. Currently Racine County, Kenosha County and Dane County allow retired officers to carry concealed weapons under the federal "Law Enforcement Officers Safety Act of 2004," also known as Public Law #108-277 (HR218).

Chief Wahlen informed committee members the City Attorney's office has worked with the Racine Police Department to create an application and agreement which will be required in order to issue a firearm. There will be a firearms qualification test, records

search, annual, prepaid, non-refundable fee of \$100.00, photographic ID card which may be recalled and rendered invalid at the discretion of the Police Chief and the issuance of the ID card by the City of Racine Police Department is at the sole discretion of the Police Chief. If an individual is issued a firearm, any actions they take are solely at their own consequence as a private citizen and have no law enforcement authority.

Chief Wahlen informed committee members there will be no cost to the City of Racine. Alderman Shakoor asked Chief Wahlen if the firearms were meant to protect the retired officers from previous incidents. Chief Wahlen stated the issuance of these firearms could prevent future disasters from occurring and is not solely for protection.

A motion was made by Vice Chair Gregory Heldingthat this be Recommended For Approval. The motion PASSED by the following vote:
